Article 1: Applicable Ind-Expo documents

1.1 The following documents are applicable to this agreement.

- Terms and Conditions for certification
- Conditions for use of logo
- Certification agreement
- Fees structure

Article 2 : General rights and obligations

2.1 Certification Committee has undertaken to ensure that the **Quality Management System (QMS)** conform to the requirements.

2.2 Ind-Expo grants the Certified Company the right to apply the **QMS** certificate mark as described in "IMSM-TCC-01" – Terms and condition for certification. This is subject to the duration of the certification.

2.3 Any changes of the certified company shall be notified to Certification body (CB).

2.4 Certified company shall keep records of all communications and actions taken in relation to **ISO 9001: 2015** standards including complaint records and remedial actions taken.

2.5 In case of withdrawal of certification, all advertising with certification logo shall be discontinued by the company certified.

Article 3: Surveillance & Recertification
