



**IND-EXPO CERTIFICATION LIMITED**  
**INTEGRATED MANAGEMENT SYSTEMS CERTIFICATION SCHEME**  
**FEES STRUCTURE**

**1. Brochure Fee: LKR 500/=**

A folder encompasses a complete set of documents required for management systems certification.

**2. Application Fee**

**GMP LKR 3000/=**

**HACCP/ ISO 22000/ ISO 9001/ ISO 14001/ OSHAS 18001: LKR 10,000/=**

This covers the cost of reviewing the Management System documents.

**3. Stage I Audit Fee:**

Stage I audit fee is computed as LKR 6000/= per auditor per man-day.

**4. Stage II Audit Fee:**

Stage II audit fee is computed as LKR 6000/= per auditor per man-day.

- Annual fee as stipulated below shall be paid before registration each year. This covers the Surveillance audit fee for the year but excludes expenses for travelling and accommodation. Where the number of products made at a facility exceeds ten, an additional fee of LKR 10,000/= shall be paid.
- In case of multi-site organizations, for the same product range an additional fee of LKR 5,000/= shall be paid for each site. If the product range differs from that of the main site an additional fee of LKR 10,000/= shall be paid for each site.
- In case of group of companies, for the first certification the fee as stipulated in the fees structure shall be charged and additional companies in the group would be given a concession of 15% for the annual registration fee of the additional certification.

**5. Annual Registration Fee:**

Categorized as per the size of the organization :

**GMP**

Category I (Less than 50 employees)	LKR 18,000/=
Category II(51 to 250employees)	LKR 25,000/=
Category III(251 to 750 employees)	LKR 35,000/=

**HACCP**

**ISO 22000/ISO 9001/ ISO 14001 OSHAS 18001**

Category I (Less than 50 employees)	LKR 35,000/=	LKR 50,000/=
Category II (51 to 250employees)	LKR 45,000/=	LKR 60,000/=
Category III (251 to 750 employees)	LKR 55,000/=	LKR 70,000/=
Category IV (751 to 1500 employees)	LKR 65,000/=	LKR 80,000/=
Category V (Over 1500 employees)	LKR 75,000/=	LKR 90,000/=

**6. Re-assessment audit fee:**

Re-assessment audit fee for renewal of certificate is computed as LKR 6000/= per auditor per man day.

7. The client shall provide transport and accommodation for auditors. Accommodation only if needed.

**8. Concession for ISO certificate holders:** Any organization obtaining more than one certification from IND-EXPO, would be given a concession of 10%for the annual registration fee of the additional certification.

**NOTE :No certification fee is charged separately.**
